This privacy policy explains how we collect, use and disclose your personal information in accordance with the requirements of the Protection of Personal Information Act (POPIA)

1. Personal Information we collect

We collect information directly from you, when you provide us with your personal details. We will inform you what information you are required to provide and what information is optional.

2. Information you provide to us

- When you directly communicate with us. We may collect personal information from you such as email addresses, phone numbers, or physical addresses when you request for our services or sign up for our newsletters. We may also use your information when there is a need to directly market to you.
- Job applications. When we post job openings and opportunities and you reply to one of these postings by submitting your application, CV and supporting documents, we will collect and process the information contained therein to assess your suitability, aptitude, skills, and qualifications for training and employment opportunities.

Information we collect through the use of our website

We collect certain information automatically when you use our website. The information collected may include your cookie identifiers, mobile carriers, mobile advertising, details about your browser, location information (including inferred location based off of your IP address), Internet service provider, pages that you have visited before, during and after using the services, information about the links you click.

We, as well as third parties that provide content, advertising, or other functionality on our website, may use cookies.

We process personal information for a variety of business purposes, including:

HOW WE DISCLOSE YOUR INFORMATION

- Job matching for training and placement purposes: We may provide personal information to our clients concerning candidates to determine if they meet job requirements posted on our website. Information is processed on a system which is managed by third party service providers.
- Disclosure to protect you, us or others. We may access, preserve, and disclose your personal information if we believe doing so is required or appropriate to: (i) comply with law enforcement and legal process, such as a court order; (ii) protect your, our or others' rights, property, or safety.

YOUR RIGHTS: ACCESS TO INFORMATION

In accordance with the POPIA, you may have the right to:

- (i) Request a copy of your personal information.
- (ii) Withdraw your consent for Afrika Tikkun Services to use your personal information.
